**Role:**

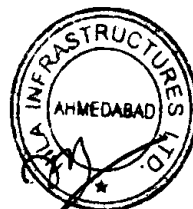
3. You will perform the duties of Independent Director in accordance with the provisions of the Companies Act, 2013, Schedule IV thereof and the Articles of Association.

4. As an Independent Directors, you will be entitled for the sitting fees for attending meetings of the Board of Directors from time to time.

5. In addition to the fees prescribed in clause no 4 above, the Company will reimburse you for all out of pocket expenses necessarily incurred in carrying out your duties in accordance with the Company's expenses policy as amended from time to time.

**External Advice:**

6. In order to enable you to carry out duties effectively you must, after consulting the Managing Director, be entitled to seek external independent advice at the company's expenses.

**Other Directorship, Business Interest and Disclosures:**

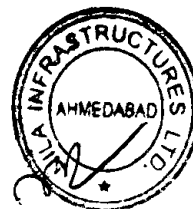
7. The Company acknowledges that you have business interests other than those of the Company and that you have declared any conflicts that are apparent at present. Under the provisions of the Section 184 of the Companies Act, 2013.
- a) every director shall at the first meeting of the Board in which he participates as director and thereafter at the first meeting of the Board in every financial year or whenever there is any change in the disclosures already made, then at the first board meeting held after such change, disclose his/her concern or interest in any company or companies of bodies corporate firms or other association of individuals.
- b) Further every director of the Company who is in any way, whether directly or indirectly, concerned or interested in a contract or arrangement or proposed contract or arrangement entered into or to be entered into-
- i. With a body corporate in which such director or such director in association with any other director, holds more than two percent shareholding of that body corporate; or
- ii. With a firm or other entity in which, such director is partner, owner or member, as the case may be, shall disclose the nature of his/her concern or interest at the meeting of the Board in which the contract or arrangement is discussed and shall not participate in such meeting:

In the event that you become aware of any potential conflicts of interest these should be disclosed to the Board of Directors as soon as they become apparent.

You shall also at the first board meeting in which you participate as Director and thereafter at every first board meeting held in every financial year give declaration as required under section 149(7) of the Companies Act, 2013.

**Code of Conduct:**

8. You will abide by the code of conduct for Board of Directors and Senior Management Personnel as adopted by the Company pursuant to the Clause 49 of the Listing Agreement with the stock exchange.
9. Further as an Independent Director you shall abide by the provisions specified in Schedule IV of the Companies Act, 2013 as to the Code of Conduct for Independent Directors, their roles, functions and duties.

12. Your performance as an Independent Director shall be reviewed annually by the nomination and remuneration committee of the Company.

**Membership of Committees:**

13. This letter refers to your appointment as an Independent Director of the Company. You may also be requested to serve on the various committees of the Board. In the event, that you are requested to serve on one or more of the Board committees this will be covered in a separate communication setting out relevant committee's terms of reference.


**Induction:**

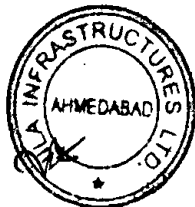
